## Improving Lives: Public and Patient Engagement - From 2012 to 31st March 2016

- Since being in shadow form in 2012, East Staffordshire Clinical Commissioning Group ESCCG) has been gathering the views of patients, carers and stakeholders on the main local health care issues. All of this work has helped the CCG to identify the care of those people with long term health issues and the care of the frail elderly as key priorities and to develop its vision for improving their lives.
- This programme of work was given the title of Improving Lives in August 2014 to make it easily identifiable and memorable.
- Since awarding the Improving Lives Contract to Virgin Care in March 2015, to come into effect in May 2016, Virgin Care have been working in partnership with the CCG to keep the public, patients, carers and local communities updated and involved.
